 - Black End Zones
 - White football lines and green soccer lines
 - Shipping and Initial Installation

- Work to be performed by companies familiar with indoor removal turf systems.
- Work to meet or exceed IFL and MASL League standards.
- Contractors must have, and maintain through entire project, workers compensation and general liability insurance. Proof of insurance or addition of insures may be requested at any time.
- Contractor is responsible for maintaining a safe working environment consistent with industry standards.
- Contractor understands the nature of the Rio Rancho Events Centers business, and that at the facility's request work could cease at any time and will need to be scheduled around the facility's event schedule.
